- **Racism**
- **Sexism**
- **Sexual Harassment**
- **Abuse: Verbal or Physical**
- **Intolerance of a person's religion, gender identity or sexual orientation**
- **Behaving in a way that disturbs the enjoyment/discussion for other people**
- **Illegal drug use or distribution on club property**
- **Any other actions deemed to be intentionally hurtful, harmful, threatening or inappropriate**

We aim to enforce the rights for all Club members to enjoy their social club in an environment that is safe and without risks to health, violence and aggression. Any violation of the Code of Conduct, or any action that a staff member finds to be inappropriate or disruptive, will result in the offending member being removed from the club.
